Section 1 Description of Good

1.1 Presentation of GISCOR:

1.4 Eligibility criteria

In order to be eligible for this call for tenders, the company must be a Nigerian structure which has a minimum experience of 01 years and which has demonstrated the capacity to Supply Tricycle and other Automobile related Goods

GISCOR reserves the right to downgrade companies whose performance in previous Tenders with it has not been satisfactory;

Section 2 Conditions for bidding

2.1 Documents to fill

2.1.1 supplier registration Form (see Annex A)

The submission form must be submitted using the standard form attached. Bidders must comply with the form and the instructions presented in the form. It is important to complete the form as clearly as possible, so that the form can be properly assessed. The information must therefore be precise and sufficiently detailed.

2.1.2 Supplier Offer Form (see Annex B)

Bidders should complete the unit cost form for all items listed to provide information that can later be used to build a budget. It is important to provide accurate and clear information so that the form can be properly assessed. GISCOR reserves the right to offer different unit costs.

2.1.4 Additional documents

- Company registration, company profile, TIN and CAC registration
- Legalized copy of the tax certificate up to 2021.
- Proof of similar services/Supplies carried out with other NGOs (including GISCOR)
- Stamped supplier registration form (Annex A).
- Stamped Supplire Offer Form (Annex B).
- An **ID** copy of the legal representative.

2.1.5 General

- All documents submitted must be in English.
- Please submit a complete application form.

2.2 Where to send

All documents related to the tender submission must be placed in two separate envelopes, as follows:

Envelope 1: Financial Offers - Supplier Offer Form (Annex B)

Envelope 2: Technical Capacities of the Company - all other forms and documents

The envelopes must be clearly labeled with the following information:

Envelope 1: Financial Offer, Company Name, and Reference Number

Envelope 2: Technical Capacities, Company Name, and Reference Number

All envelopes must be sealed and delivered by hand or via courier service to the Tender-Specific Box. The bidder's representative delivering the offer must obtain a receipt and the RFP record of delivery in the tender-specific log-book.

Tender submissions must be made to the following address:

In addition to hand-delivery or courier, bidders may submit their tender via email to <u>Procurement@giscor.org</u> The email subject line should clearly state the reference number. Bidders must separate their technical and financial offers into two separate zipped documents.

Please note that failure to comply with any of these conditions will result in disqualification.

2.3 Deadline for receipt

Proposal must be provided no later than 16:00hours on Friday 14th April 2023. Quotes received after the stated deadline are considered invalid.

2.4 Questions / Clarification requests

Applicants can send their questions, before the 10th/04/2022. As regards the result of the call for proposals, no further information will be given to applicants before the selection committee has made its final decision.

Section 3 Evaluation of application files

The RFPis awarded to the bidders who have submitted the highest rated bid among those that comply. The evaluation will be carried out by the Tender (RFP) Analysis Committee on the 17th April 2023 and will take place as follows:

- 1) Examination of the admissibility and conformity of the offers (Tender opening).
- 2) Evaluation of the technical quality of the bid 70 points
- 3) Evaluation of the financial offers (by comparison of the prices) 30 points

3.1 Administrative verification

Upon opening of the application forms, an administrative evaluation will be performed. This will entail a thorough scrutiny to determine the registration status of the company/supplier/business with the Cooperate Affairs Commission. The Bid Opening Committee will conduct this search through the CAC Portal at https://search.cac.gov.ng Notably, businesses that are not registered will be deemed ineligible, and those registered with a status of "INACTIVE" will also be disqualified. Furthermore, the Bid Opening Committee will assess the envelopes to confirm if they were received within the set deadline, whether they are appropriately sealed with no indication of tampering, and if they have the required reference to the call for tenders. Failure to meet any of these conditions will result in disqualification of the bid.

3.2 Qualitative/Technical assessment (70 Points)

All application forms that have been deemed compliant at the administrative verification stage will be qualitatively assessed by GISCOR according to the following criteria.

3.3 Financial evaluation: (30 points)

This analysis is carried out on the basis of the costs as specified in Annex B.

Propose a price for each category of vehicles;

The analysis commission will establish an average price per article for each tenderer by calculating the arithmetic mean of the prices proposed by the said tenderer according to the different sections. It remains that for the successful bidder, the purchase orders will remain based on the unit prices that he has proposed by tranche.

The score of 30 points is awarded to the tenderer whose offer is the lowest. GISCOR reserves the right to reject any offer whose financial part is deemed too low, unviable or incompatible with the performance of the proposed work.

Formula for the financial note: <u>lowest bid amount</u> x 30

Amount Bid Bidder

For reasons of possible budgetary availability and programming, GISCOR reserves the right to propose the signing of the RFP for all or part of the services appearing in the request for quotation. If the provisional successful bidder declines the proposal to sign the Tender for this reason, the award passes to the next competitor, in the order of classification obtained at the end of the counting.

Make sure to provide costs that are according to the market and that will allow GISCOR to analyze your case adequately;

3.4 Final evaluation

The selection committee recommends the awarding of the Tender to the supplier having obtained the best score following the final technical and financial analyses.

Final score: technical analysis note + financial analysis notes

In the event of a tie in the final score, the Tender is awarded to the Company who submitted the lowest price.

GISCOR reserves the right to sign a framework agreement with several Companies for the same types of services;

3.5 Business Behaviour

The conduct of the Company should not violate the basic rights of GISCOR's beneficiaries.

The supplier should not be engaged

- a) in the manufacture of arms
- b) in the sale of arms to governments which systematically violate the human rights of their citizens; or where there is internal armed conflict or major tensions; or where the sale of arms may jeopardize regional peace and security.

3.6 Cancellation of the RFP procedure

If a RFP procedure is cancelled, tenderers will be informed by the Tendering authority.

A cancellation may occur, for example, if:

• The RFP procedure has not been completed, i.e., when no suitable, qualitatively or financially acceptable offer has been received or there has been no valid response from the all; The economic or technical parameters of the project have fundamentally changed;

- Exceptional circumstances or a case of force majeure make the normal implementation of the project impossible; All technically acceptable offers exceed the financial resources available.
- There have been substantial errors, irregularities or fraud in the procedure, in particular where these have prevented fair competition; the award is not in accordance with sound financial management, i.e., it does not comply with the principles of economy, efficiency and effectiveness (for example, the price proposed by the Company to which the Tender is to be awarded is objectively disproportionate to the Tender price.

4.7 Appeals

Bidders who believe they have been harmed by an error or irregularity during the award process may request more information from GISCOR and appeal.
